

Fueling American Jobs Coalition Launches New Ad Campaign Urging Trump to Stand with American Workers on RFS

WASHINGTON, D.C. – The Fueling American Jobs Coalition announced today the launch of “Betray,” a new ad campaign urging President Trump to stop caving to the ethanol lobby. If the president doesn’t change course, he runs the risk of turning his back on the American manufacturing workers who helped make his presidency a reality. Fueling American Jobs Coalition’s members include a wide range of U.S. companies including independent refiners, unions and small businesses.

“Betray” refers to President Trump’s failure to consider any reforms to the outdated Renewable Fuel Standard (RFS), which protects windfall profits for large integrated oil companies and massive fuel retailers, while placing an unfair burden on independent fuel refiners and gas stations. The president’s refusal to fix the RFS could put 75,000 to 150,000 U.S. jobs at risk.

Last week, the *Wall Street Journal* editorialized against President Trump’s refusal to stand up to the ethanol lobby:

Nine United States Senators recently sent [a letter](#) to the President, echoing concerns that American workers would be left behind by the Administration's refusal to take action on the RFS. In the letter, the Senators requested a meeting with the President, "regarding RFS and pro-jobs policies with us, our Senate colleagues who previously lobbied on behalf of the ethanol industry, and relevant members of your administration, to discuss a pathway forward toward a mutually agreeable solution that will also save refining jobs and help unleash an American energy renaissance."

"Betray" will begin airing on Fox and Friends and across digital platforms throughout the week.
